4.2 Newsletter

Wendy advised the newsletter has been held over for a short period to accommodate the news resulting from the AGM and subsequent SMC meeting.

4.4 AERA

Delegates to be appointed at the next meeting. Currently the delegates are Sandy and Jane.

5. GENERAL BUSINESS

- Meeting Schedule: Discussion of venues including EFA rooms in Werribee. Jen Green to arrange meeting schedule approx. 6 weeks apart. Debi Chisholm asked for consideration of the ride dates when arranging meeting dates. Feb 3rd agreed for next meeting in respect of the large amount of items to address quickly.
- 5.2 **Points & Distance:** Lissy enquired about the VERA points and distance awards for 2008 and it was agreed they should go ahead as normal.
- 5.3 **Bio Security:** Chris brought up the need to address Bio Security at endurance rides as a matter of priority. A sub Committee was formed immediately consisting of Chris Gates, Debi Chisholm and Sandy Horton reflecting their experience and current dealings with the subject matter. They will report back to the SMC as soon as possible.
- 5.4 **FEI and VERA Points Scores:** Jane raised the issue of the awarding of FEI points in the VERA Points score system. Jane gave a history of the allocation methods. Wendy Bootle (guest) advised the data base does not allow for FEI points to be allocated currently and Jane advised that Ian Blucher can update this. General discussion regarding this issue from the floor (guests) and the SMC resulted in an informal poll of those in attendance. The poll revealed 16 in favour of awarding FEI points in some way, and 18 against. The issue will be put on the agenda for the next SMC meeting.
- 5.5 **Rider Bib Policy:** Belinda Kolek (Guest) asked for clarification of the bib policy citing difficulty understanding it in its current form. Linda and Lorraine responded to the query and advised it will be clarified for all ASAP and posted to the website and included in the newsletter.
- 5.6 **AERA Waiver:** Lorraine referred the SMC to a proposed AERA Rider Waiver and general discussion took place regarding the wording of same. In particular the words 'all costs' were referred to as being open to too much interpretation and Lorraine advised independent legal counsel had suggested that the words be replaced by "all reasonable costs". AERA will need to address this concern. This is to be discussed further at the next SMC meeting.
- 5.7 **2008 Tom Quilty Proposal:** Jane raised the issue of a Queensland club proposing to run a Tom Quilty in 2008 despite the AERA decision to defer the 2008 Quilty to 2009. SMC members will discuss further and advise their position on the matter ASAP.
